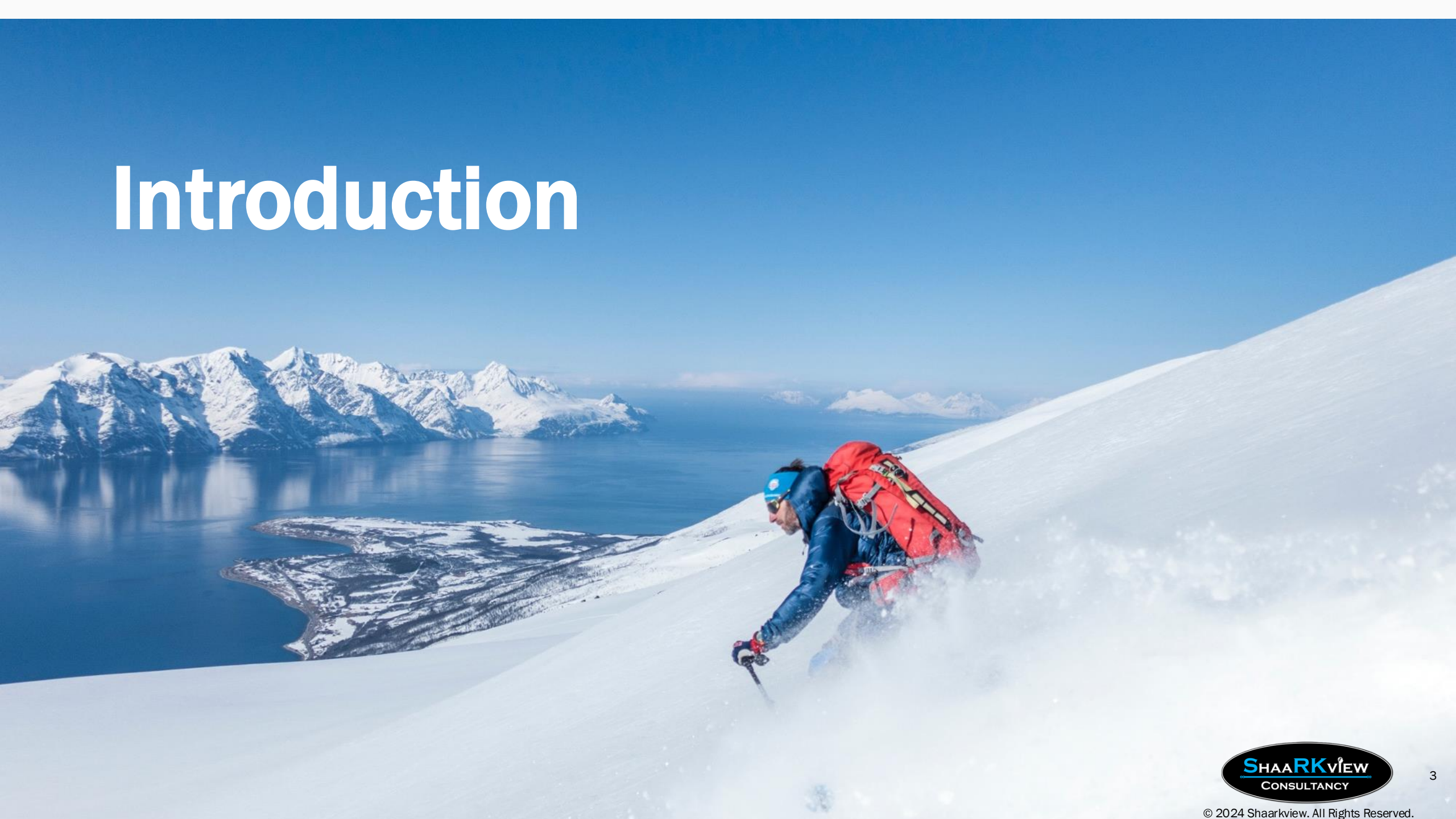

- Basics

- The Certified Quality Auditor (CQA)<sup>[1]</sup>
  - Is a **professional** who **understands** the standards and principles of auditing and the auditing techniques of examining, questioning, evaluating and reporting to **determine** a quality system's adequacy and deficiencies.
  - **Analyzes** all elements of a quality system and **judges** its degree of adherence to the criteria of industrial management and quality evaluation and control systems.

## • Requirements and Education

### REQUIREMENTS

8

**Years of on-the-job experience in one or more of the areas of the Certified Quality Auditor Body of Knowledge.**

Candidates must have worked in a full-time, paid role.

\*A "Decision-making" position is defined as the authority to define, execute, or control projects/processes and to be responsible for the outcome. This may or may not include management or supervisory positions.

3

**\*Years of on-the-job experience must be in a "Decision-making" position.**

### EDUCATION

Candidates who have completed a degree from a college, university or technical school will have part of the eight-year experience requirement waived, as follows (only one of these waivers may be claimed):

- **Diploma from a technical or trade school** — one year waived
- **Associate degree** — two year waived
- **Bachelor's degree** — four years waived
- **Master's or doctorate** — five years waived

# Overview of CQA Certification Program



## • Examination

- Each certification candidate is required to pass an examination that consists of multiple-choice questions that measure comprehension of the Body of Knowledge.
- **Computer Delivered** - The CQA examination is a one-part, **165- multiple choice question exam** and is offered in **English only**. **150** multiple choice questions are **scored** and **15 are unscored**. Total appointment time is five-and-a-half-hours, exam time is **5 hours and 18 minutes**.
- **Paper and Pencil** - The CQA examination is a one-part, 150- multiple choice question, five-hour exam and is offered in English only.
- All examinations are **open book**. Each participant must bring his or her own reference materials. Use of reference materials and calculators is explained in the **FAQs** <sup>[2]</sup>.

### • Case Studies

- The CQA examinations will continue to present a number of case studies. Each case study will include a **brief scenario outlining critical details** about an audit situation. In addition, each case study will be supported by related audit documents.
- Approximately **10 percent to 15 percent of the test** will be devoted to these case studies.
- Although the questions related to these cases will use the same four-choice answer format as the rest of the test, the use of scenario details and sample documents will allow the candidates to **apply their critical thinking skills** in evaluating realistic situations and accompanying documents, memos, etc.

## • Recertification <sup>[10]</sup>

- To maintain the integrity of your CQA certification, ASQ requires that you recertify **every three** years.
- Find out the steps you need to take for [recertification](#) <sup>[10]</sup>.
- CREDENTIAL HOLDERS MUST:
  - Obtain 18 recertification units (RUs) within a three-year recertification period.
  - Or
  - Retake the certification exam at the end of the 3-year recertification period.

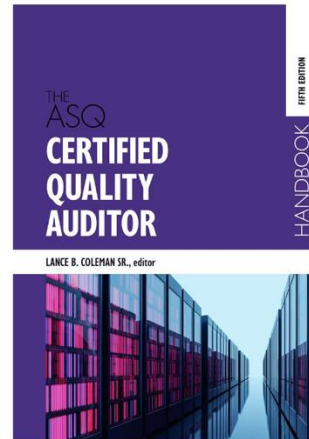
